I wanted to update you about an ongoing initiative about holding the first meeting of "Celebrating Women in Statistics: Know Your Power" in 2014. This conference will be held in Research Triangle, North Carolina, during May 15-17, 2014. This is a joint initiative between CWIS and the Committee of Women in Statistics (COWIS). We have submitted an NSF proposal to support this conference and many are working on submitting other proposals as well. The committee assignments, the programs, and the list of speakers are being developed. We will keep you posted about further developments regarding the conference I encourage you to get involved with this initiative and plan to attend the conference. I also wanted to make you aware of the many possible awards for which women can be nominated: Award of Outstanding Statistical Application; the COWIS-Gertrude M. Cox Scholarship; the Deming Lectureship; the Edward C. Bryant Scholarship; the Excellence in Statistical Reporting; the Founders Award; the Noether Award; The Samuel S. Wilks Memorial Medal; W. J. Dixon Award; W. J. Youden Award in Interlaboratory Testing and the Waller Education Award. With limited manpower, it is hard for CWIS to make the full nomination packages for all these awards. However, we can forward the possible nominations to the COWIS leadership for them to prepare the full packages for these awards.

This newsletter also contains interesting and important information for you to read regarding our activities. Thanks for your continual support.

## Note from the President-Elect

Dear Colleagues,
In case you missed it, I want to call your attention to the recent article on gender biases (Moss-Racusin et al., 2012, Proceedings of the National Academy of the United States www.pnas.org/cgi/doi/10.1073/pnas.1211286109). They conducted a randomized double-blind study ( $\mathrm{n}=127$ ) in which science faculty from research-intensive universities rated the application materials for a graduate student laboratory manager position. Identical applications were sent out for review, but in some the applicant had a male name and in some female name, and which faculty got applications associated with gender was random. Applications with male names were rated as significantly more competent and hirable than identical applications with female names. Reviewers also selected a higher starting salary and offered more career mentoring to the male applicant. In addition, women and men faculty both favored male applicants.

The authors claim novelty in using randomization to investigate gender bias in academia. But any of the alumni of the Pathways to the Future Workshops that Lynne Billard ran for decades can tell you otherwise. The results from Moss-Racusin et al. (2012) corroborate a study by M.A. Paludi and W.D. Bauer (Goldberg revisited: What's in an author's name. Sex roles 9, 387-390, 1983) in which identical manuscripts were sent out to faculty for review with the author randomly being listed as John T McKay, Joan T. McKay and J.T. McKay. Paludi and Bauer extended to include male reviewers the earlier randomized study by P.A Goldberg (Are women prejudiced against women? Transactions 5, 28-30, 1968) in which the reviewers were all college girls.

Although the conclusions of the 2012 study are disappointing, it is very important to see. Studies from 1968 and 1983 are so old that one could wistfully argue that our culture had evolved. Conclusions, either way, from non-randomized studies just don't pack the same punch as do conclusions from randomized studies. Now we know that our work is not done. We must renew our efforts to insure that women's creativity and output is not devalued because of her gender.

If anyone has ideas regarding new ways in which the Caucus for Women in Statistics can do more to recognize and honor excellence in women statisticians, I would love to hear from you.
